THE FACT BOOK is produced annually by the U.S. Office of Personnel Management (OPM) as a convenient reference suitable for a variety of audiences. It contains descriptive statistical information, using tables and charts, about many aspects of the Executive Branch workforce. Note that data for the U.S. Postal Service are excluded from all tables except those on pages 8 and 64, and the tables in Part 4. Both historical and current data are displayed, resulting in a comprehensive snapshot of the Federal worker -- personal and professional characteristics, employment levels, and benefit payments and contributions. The statistical tables and charts in THE FACT BOOK are based on data from a wide range of sources, each of which is cited on the appropriate page with telephone contacts and email addresses if available.








The "Typical" Federal Civilian Employee, 2006 Individual Characteristics





Occupational Category








The "Typical" Federal Civilian Employee, 2006 Job Characteristics (Continued)








Average Adjusted Basic Salaries and Full-Time Employment by State (10 Highest Only)







for General Schedule Employees All Areas, Full-Time Only (1980 - 2006)





















Executive Branch Employment of Women By General Schedule (GS) and Related Grades 1998 - 2006






















Executive Branch Performance Recognition For Non-Senior Executive Service Employees








Allocated vs Appointed

Career vs Non-Career







Executive Branch Senior Executive Service: Awards 1996-2006




Performance Awards
















Executive Branch Retirement SystemOn Annuity Roll at End of Fiscal Year






Operating Revenues and Expenses, Fiscal Year 2006












